- F. State of WI Levy Limits: Discussion: The budget restraint report filed shows the Village

General Fund increase is 3.31 percent from 2020 to 2021 which disqualifies the Village. The Legislation allows a 2 percent increase.

- 1. Fifth Amendment to Metro Paramedics Contract. Chief Austin has reported: Due to the termination of the two tenured PPP's, the newly hired personnel will be paid a starting wage.
